	Sensitive financial information is collected & shared solely & exclusively with co-agency (where appropriate) and Notary to comply with anti-money laundering laws (LFPIORPI).
What do we use your personal data for?	LCRE may collect your personal data in different ways: when you provide it to us directly; when you visit our website or use our online services, and when we obtain information through other sources that are permitted by law.
